

APPROACH LIMITED – Warranty Policy

APPROACH LIMITED components and products come with guarantees that cannot be excluded under Consumer Laws. You are entitled to a replacement or refund for a major failure. You are also entitled to have the goods repaired or replaced if the goods fail to be of acceptable quality and the failure does not amount to a major failure.

APPROACH LTD warrants the goods manufactured or sold shall be free of defects in materials or workmanship for one (1) years, unless otherwise stated, from the date of purchase by the original purchaser. All documents in the warranty request shall include (but not limited to) the original retailer's sale document, receipt identifying the Product and date of purchase, details of the defect and a return address .

APPROACH LTD makes no warranties that its products are fit for a particular purpose.

APPROACH LTD's liability shall be limited to the repair or replacement, at its discretion, of any defective product.

This warranty does not apply to any costs in removing and reinstalling any defective product including delivery by the Customer of any product for testing by APPROACH LTD in respect to any claim.

You may also have other legal rights which vary from state to state, and country to country, when selling APPROACH LIMITED products. This warranty is not affected by those rights and therefore APPROACH LTD is not liable for additional warranty by law.

WARRANTY EXCLUSIONS

This warranty will not apply where the defect arises due to any of the following:

- Use of the Product in an assembly for which it was not designed.
- Use of the Product in an assembly that APPROACH LTD has not designed or/and manufactured.
- The incorrect installation or removal of, or attempt to repair the Product.
- Damage due to improper storage and handling of the product, non-observance of operating instructions, or insufficient care and maintenance.
- Damage in transit in forwarding the Product to APPROACH LTD.
- Lack of technical skill, competence or experience of the user.
- Poor maintenance, unauthorised modification, or improper, negligent or careless use of the Product.
- Use of the Product in a competition or for commercial purposes such as (but not limited to) commercial, rental or teaching environments.
- The Product, of which it is a component, being abused or involved in an accident.
- Damage or deterioration to the surface finish, aesthetics, rust, oxidation or appearance of the Product.
- Damage or deterioration to the surface, aesthetics, or appearance of the bar grip.

WARRANTY FURTHER CONDITIONS

- APPROACH LTD's liability under this warranty is limited to repairing or replacing and returning the defective Product to the purchaser. A purchaser making a claim must bear the cost of sending the Product to APPROACH LTD and any cost in removing, refitting or readjusting the Product in assembly.
- This warranty will not apply to a Product that is a component in a sale of a complete product whether pre-assembled or subsequently assembled. In such instance any claim should be made to the retailer or other entity from whom the product was purchased or the manufacturer or other entity liable by law.
- Retailers and wholesale outlets for APPROACH LTD Products cannot modify this warranty in any way. Any alteration will only be binding to APPROACH LTD if it is in writing and signed by a Director of APPROACH LTD.
- It is the purchaser's responsibility to regularly examine a Product to determine the need for, and attend to, normal service or replacement.
